We went fine free and waved over \$6,000 in old fines from 707 patrons. Cleaning Gals is changing to Above and Beyond Cleaning Crew. Same people, but one is retiring. There is a draft letter that is suggested to be sent to the local churches. The letter is about people who have been released from the County Jail and need assistance. They are usually not fed the day of release and staff has bought lunches for these people multiple times. The letter asks the churches to donate some non-perishable food goods to keep on a shelf for when this happens.
