The first summer lunch partnership through Gather2Grow from Feeding America has been held with 15 lunches served.

Concert in the Park – Bad weather resulted in a poor turnout for June. Next concert will be held on July 13<sup>th</sup>, baked goods appreciated for the Friends. Another concert on August 10 and September 14.

We have 26 adults signed up for the Summer Reading Program.

We have had three staff out with Covid at the same time.

No news on the new round of the ECF funding.

We will not be renewing our contract with Barton's Cutting Edge Landscaping as they are very difficult to contact and are not cutting the property in a timely fashion.

The Pig Roast this year will be held August 19th.

Next year, 2023, will be the 150<sup>th</sup> birthday for the city of White Cloud and our pig roast will be July 7.

Millage payments for 2021 have been received.

We will be switching vendors to Spectrum, which will result in paying half of what we currently pay for phone service through ATT.
